There is a grant request into JCCF for a Glowforge for the makerspace. The Glowforge website describes their machine as built on laser cutter & engraver technology, using a beam of light the width of a human hair to cut, engrave, and shape designs from a variety of materials. Very cool. Purse Bingo has been officially postponed until April 7, 2021.

The initial 'One for the Books' evenings have been tentatively scheduled for September 18 and October 2. Awaiting RSVPs.

# EXECUTIVE SUMMARY OF REQUESTED ACTION BY LIBRARY BOARD

# Additional Appropriation Hearing

The Library is funding this Project through the issuance of general obligation bonds. The proceeds from this bond issue must be appropriated prior to being spent on the project. Notice of this hearing was advertised in your local paper.

(Open the meeting up to the public for a hearing on the use of the bond proceeds for the project.)

# Additional Appropriation Resolution (Exhibit A)

After the hearing on the additional appropriation, the Library Board must approve the appropriation of the bond proceeds to be spent on the project costs before any bond money can be expended. Unlike appropriations of tax dollars, this additional appropriation of bond proceeds is not required to be approved by the Department of Local Government Finance.

#### Final Bond Resolution (Exhibit B)

This Final Bond Resolution establishes the amount to be borrowed, maximum term of repayment and maximum interest rate. It also contains the details about the bonds, such as the form of the bond.

The resolution also authorizes the publication of the Notice of Sale of the Bonds and establishes the maximum cost an underwriter or bank may bid for the bonds. It also establishes a bid committee who will award the bonds to the lowest bidder.

This resolution also approves the form of the Master Continuing Disclosure Undertaking and the Registrar and Paying Agent Agreement. The Securities and Exchange Commission requires that a library enter into a Master Continuing Disclosure Undertaking before it issues bonds. The Library has entered into this type of agreement previously. It basically requires that the Library agree to annually provide certain types of financial information to the SEC's EMMA database and provide notice of certain material events on a timely basis.

# EXCERPTS OF MINUTES OF A MEETING OF THE BOARD OF TRUSTEES OF GREENWOOD PUBLIC LIBRARY

A meeting of the Board of Trustees (the "Board") of Greenwood Public Library (the "Library") was held at the Greenwood Public Library, Greenwood, Indiana, on September 8, 2020, at the hour of 6:00 p.m. (Local Time), pursuant to notice duly given to all members of the Board in accordance with the rules of the Board.

The meeting was called to order by the President of the Board, and the minutes of the meeting were recorded by the Secretary of the Board.

On call of the roll the members of the Board were shown to be present or absent as follows:

(Among other proceedings had and actions taken were the following:)

The Secretary presented to the Board proof of publication of the notice to taxpayers of the hearing to be held at this meeting on the matter of the additional appropriation proposed to be made on account of the renovation of and improvements to Greenwood Public Library (the "Project"), which proof of publication show that such notice was published in the <u>Daily Journal</u> on August 19, 2020.

On motion duly made, seconded and carried, the proof of publication and posting were ordered approved and made a part of the records of this Board.

The President of the Board then stated that the Board was now ready to hear all taxpayers desiring to be heard in respect to the matter of the additional appropriation in the amount of \$3,940,000 proposed to be made on account of the Project.

After hearing all taxpayers present who desired to be heard relative to said additional appropriation, on motion duly made, seconded and carried, the resolution attached hereto as <a href="Exhibit A">Exhibit A</a> was adopted by a majority vote.

On motion duly made, seconded and carried, the Secretary or Assistant Secretary of the Board was directed to advertise the sale of the bonds heretofore authorized.

The firm of Ice Miller LLP, bond counsel of Indianapolis, Indiana, had been consulted relative to the procedure to be followed in connection with the proposed bond issue and the

rendering of an opinion approving the legality of the bonds. The Board was then presented a form of resolution for adoption for the purpose of authorizing the issuance of bonds.

After due consideration of the final bond resolution, on motion duly made, seconded and unanimously carried, the same was adopted and is attached hereto as Exhibit B.

It was then stated that the Board needed to consider and approve the Post Issuance Compliance Procedures (the "Procedures"). After reviewing the Procedures, the Board approved the resolution attached hereto as <a href="Exhibit C">Exhibit C</a>.

Upon motion made and seconded the meeting adjourned.
